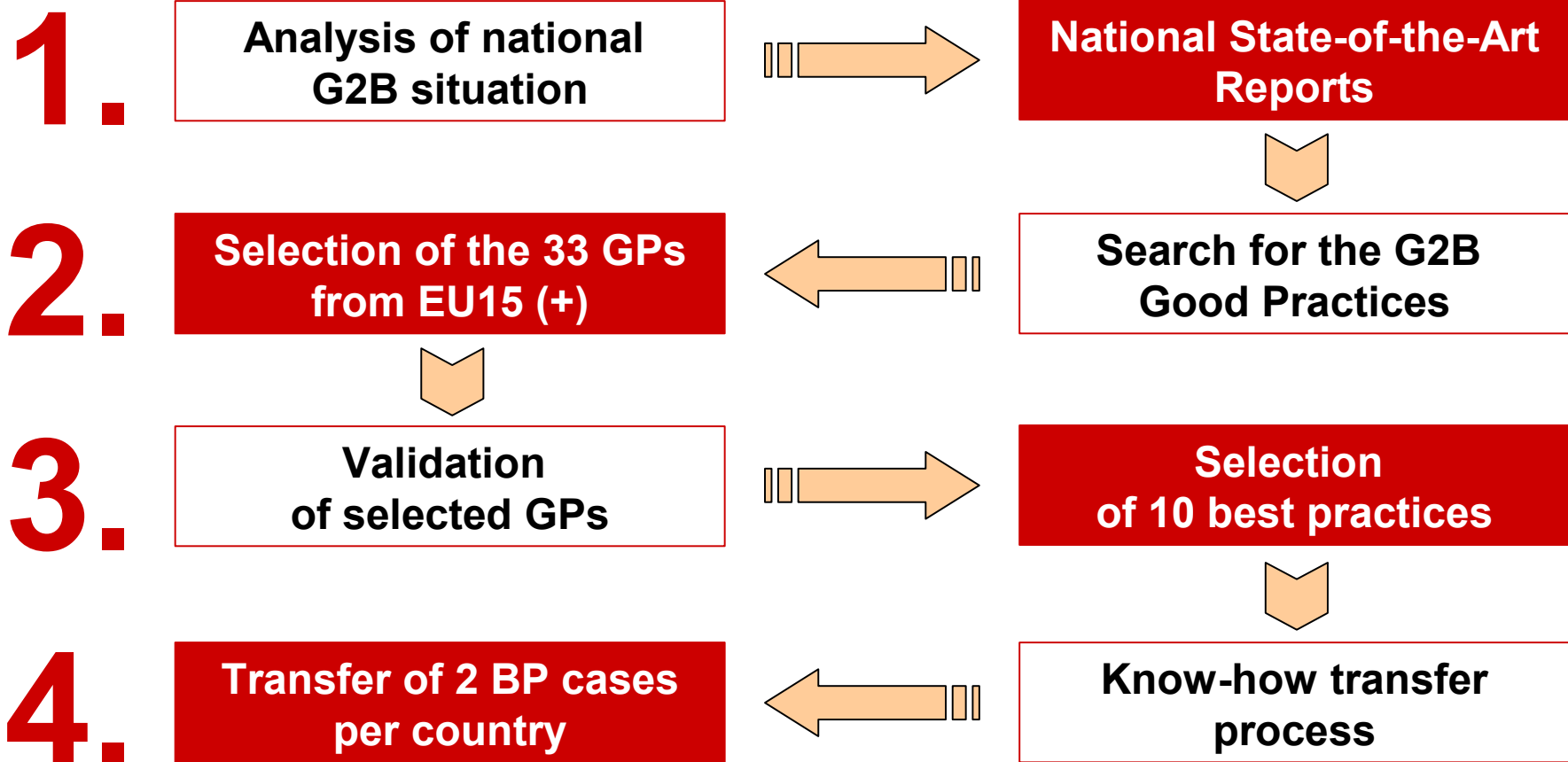

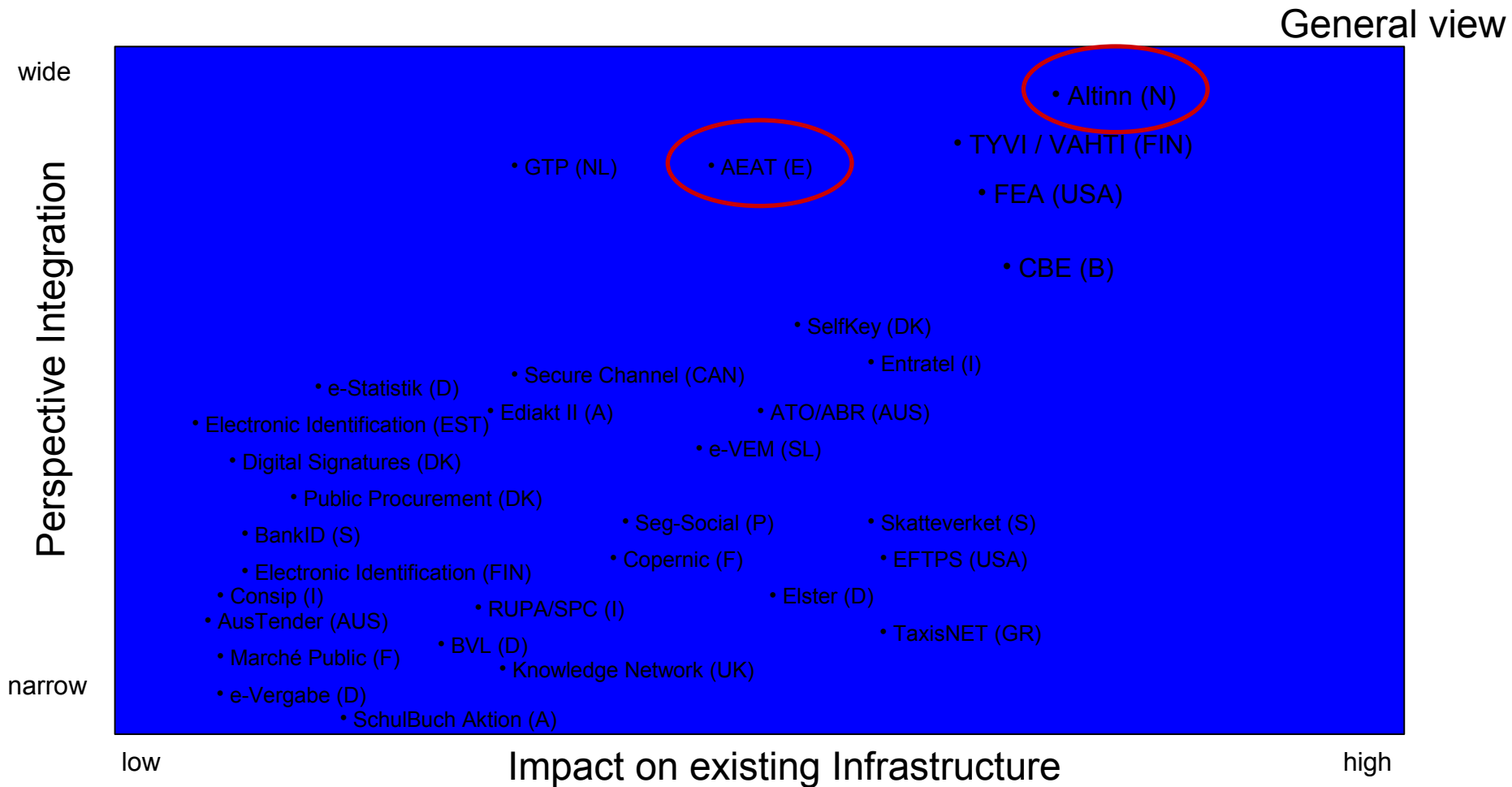

# Access to e-Gov Services Employing Semantic Technologies

- Project Acronym: Access-eGov
- Programme: FP6, IST
- Duration: January 2006 – February 2009
- Effort: 410 person-months
- Total budget: 2 279 243 EUR
- EC Contribution: 1 983 000 EUR
- Coordinator: Technical University Kosice, SK
- Consortium: 11 partners, 5 countries (Slovakia, Germany, Greece, Poland, Egypt)
- Pilot applications: SK, PL, Germany, Egypt

# Access-eGov: Problem – Objective - Outcome

- Problems faced by citizens/businesses:
  - How to find the service relevant to their life-event?
  - How to combine atomic services into a scenario of services leading to the expected outcome?
- Project objective:
  - To develop and validate an IT platform for composition of governmental services into complex process definitions (life events) enabling semantic interoperability of traditional and electronic government services.
- Project outcomes:
  - **Annotation Tool** - used by public administration for an easy registration of PA services into the AeG system
  - **Personal Assistant Client** – used by citizens: a) to discover relevant PA services; b) to compose them into a user scenario (to and achieve the goal of the life event); and c) to execute the services
